Faith, Hope and Charity

In the Standard Work for our Grand Jurisdiction, the suggested closing prayer asks that, "...may we daily increase in Faith, Hope, and Charity; more especially that Charity which is the bond of peace and the perfection of every virtue."

The plain text of the Entered Apprentice Master's Lecture reminds us that the three principal rounds of Jacob's Ladder are Faith, Hope, and Charity. We are to have Faith in God, Hope in immortality and Charity for all mankind. The lecture also tells us that faith may be lost in sight, hope may end in fruition, but Charity expends beyond the grave.

What might all this mean?

"Faith may be lost in sight," suggests that once something hoped for or believed in is fully realized or seen, the need for faith in it diminishes. Faith involves trust in the unseen or the unknown, so when evidence or tangible proof replaces uncertainty, faith is no longer required. This concept is often used in spiritual or philosophical contexts, implying that faith serves its purpose until the truth or reality is revealed.

"Hope may end in fruition" implies that hope, which is the anticipation or desire for something, reaches its fulfillment when that desired outcome is achieved. In other words, once what is hoped for becomes reality, hope transforms into fruition - the realization or attainment of

what was longed for. This concept highlights the idea that hope serves as a motivator and source of comfort until the moment the aspiration or goal is fulfilled.

"Charity extends beyond the grave" suggests that acts of love, generosity, and selflessness have a lasting impact that continues even after one's death. It conveys the idea that the influence of charitable deeds, whether through the memories, legacies, or positive changes they inspire, can transcend the limits of an individual's lifespan. This could also reflect spiritual or religious beliefs, emphasizing that charity holds eternal value and is remembered or rewarded in an afterlife. It encourages living a life of compassion and generosity, knowing that such virtues leave an enduring legacy.

Faith, Hope and Charity. Each revealed one by one when we are ready to embark on a journey in search of the true word. In this Degree we hear an expanded version of these virtues.

Faith in ourselves, our fellowman, and in a God that is infinitely wise, good, merciful, and loving.

Hope in the ultimate triumph in Masonry. Hope that will make all men one family, in the cessation of war and bloodshed and Hope that the downfall of all temporal and spiritual tyranny will bring peace and liberty everywhere.

And Charity (taught to us by Faith and Hope); for the faults and injustices of others, and that teaches us to only do to our fellows that which we should feel right and merciful for them to do to us.

The 18th Degree also provides further explanation as to the importance of Charity because it is Faith and Hope put into action. Charity is the chief virtue and the first law of Masonry. It is only with the assistance of Faith, Hope and Charity that we can discover the true word. So what is Charity?

It can be considered as the selfless act of giving love, assistance, or resources to others without expecting anything in return. It can take many forms, such as helping those in need, supporting a good cause, or showing compassion and kindness in everyday interactions. Charity is about fostering generosity, empathy, and a sense of shared humanity.

In many spiritual or philosophical traditions, charity is seen as a virtue of great importance, often linked to the idea of unconditional love or goodwill towards others. In the 18th Degree of our Scottish Rite, we again hear of It's not just about material giving; it also includes offering time, understanding, and emotional support to uplift and benefit others.

> Charity as the Bond of Peace suggests that charity, or selfless love, unites people and creates an environment of peace. When individuals act with love and compassion, conflicts diminish, and mutual understanding flourishes, binding people together in harmony.

> Charity as the Perfection of Every Virtue: implies that charity is the highest and most complete expression of all virtues. Qualities such as kindness, humility, patience, and justice are perfected when they are motivated by pure love and a desire to do good for others.

Charity is not just one virtue among many but the foundation and culmination of all virtues, making it essential for both personal growth and a harmonious society. And, for Masons, essential to our search for Light. Faith and Hope are internal, Charity is external.



Ill. Brother Henry M. "Scoop" Jackson, 33°

Brother Henry Martin Jackson was born in May 31st, 1912 in Everett. Growing up he attended public schools and worked as a paper boy for The Herald, making deliveries along a route which included family homes, houses of ill repute and speakeasies. Seeing



that he was working as a paperboy for the Everett
Herald, he picked up his nickname, "Scoop," from
his sister Gertrude because she found her brother had
a penchant for causing mischief and getting others to
do his work for him, much like a club reporter
named Scoop featured in a comic strip at the time to
which, it stuck with him the rest of his life.

Brother Scoop Jackson completed his four (4) year undergraduate degree at Stanford and graduated from the University of Washington Law School, where he received his Juris Prudence Degree in 1935. At the age of 26, he was elected as the Snohomish County prosecuting attorney in 1938. Two years later, in 1940, he won his first congressional seat in the House of Representatives as the Washington State 2nd District Congressman. He ran for re-reelection and served 12 years (1941-1953) and filed for and ran for the United Stated Senate in

1954. At which time he worked with Warren Magnuson, the other United States Senator from the State of Washington and remained as a United States Senator until his death on September 1st. 1983. Together, Magnuson and Jackson used their legislative skills and seniority to secure significant federal

funds for Washington state and enact landmark legislation in various areas.

Brother Jackson started his Masonic life in 1928, where he was initiated as a member of DeMolay in Cascade Chapter, Everett, Washington at age of 16. His DeMolay awards through his life included both the Chevalier Degree and the Legion of Honor.

Brother Jackson continued his journey into the Ma-

sonic Life in 1939, by petitioning Everett Lodge #137 in Everett, Washington and was initiated an Entered Apprentice on April 17, 1939, Passed to the degree of Fellow Craft Mason on July 24, 1939 and on October 16, 1939, He was raised to the subline degree of a Master Mason.

Brother Jackson submitted a petition to the Valley of Everett Scottish Rite on November 25, 1940 and on a humorous note, on his petition he stated his occupation was "Congressman-Elect." Brother Thomas E. Shagg and Brother Howard Cross were the first and second signers on his petition. Brother Jackson being a Master Mason and upon completion of the mandatory degrees, he was so designated as a 32° Degree Scottish Rite Mason January 8th, 1941 and was a member of the Valley of Everett Scottish Rite. On October 18, 1971, Brother Jackson was invested with the honorary degree as 32°, Knights Commander Court of Honor 32° KCCH, November 18th. 1971 and was coroneted a 33°, Inspector General Honorary (IGH) in the fall of 1977.

Late in life, Brother Jackson, as a Senator for the State of Washington met the love of his life, Ms. Helen Hardin and they were married on December 16, 1961 and had two children, a daughter, Anna Marie and his son, Peter Hardin Jackson.



Brother Jackson also petitioned to be a Noble in the Shrine Nile Temple and was approved and upon initiation, he was considered a Shrine Noble in good standing. Our Brother was also active in Royal Order of Jesters, as well as on the advisory board of the Evergreen Council of the Boy Scouts of America and life member of Normanna Lodge #3.

In the Washington Masonic Tribune dated September 12th, 1983, Bro. Harry M. Lehrbach stated in his article "Farewell Dear Friend and Brother", reflecting on the passing of Brother Jackson. In his article, he relayed a conversation he had with Brother Jackson concerning that when Mason "gets elected, then when they get into office and where their time is committed up to their chins, they catch it from the fraternity for not participating in Masonic events. "Brother Jackson stated, It comes with the territory. But I still try to exact my Masonic efforts

to my first love," DeMolay." He was a true believer about DeMolay as indicated by the following statement which was communicated by Brother Jackson himself, "The more things change, the more they re the same. Regardless of the great changes in our society, there is something immutable about DeMolay. The molding of the character and the integrity of young men, that's the greatest accomplishment of DeMolay. By service the Order of DeMolay, we can bring the light of ideals into the lives of young men."

Bro. Lehrbach also stated in his article concerning Brother Jackson's Masonic duties, "But that is far from all he did for Masonry. But he continuously tried to help his Brethren when they ever requested it, and some requests were pretty zany."

Our Brother who was summoned by the Great Architect of the Universe, when he laid down his Masonic tools on September 1st, 1983, and was called to the Great Celestial Lodge Above from whom no traveler return. Prior to his passing, our Brother, Henry M "Scoop" Jackson had four (4) great loves, His Family, His God, His Country and the Masonic Fraternity.

Scottish Rite Symbolism The Rose Cross

The Rose Cross, also known as the Rosy Cross or Rose Croix, is a symbol with deep esoteric and mystical significance. It features a cross with a rose at its center, which can be red, white, or golden. This symbol is associated with the Rosicrucian Order, a mystical and philosophical secret society that emerged in the early 17th century.

The Rose Cross symbolizes the teachings of Western esotericism based on Christian tenets. The cross represents the human body, while the rose



signifies the individual's unfolding consciousness. Together, they symbolize the union of the spiritual and the material, the divine and the human.

The Rose Cross has been used by various esoteric groups, including the Order of the Golden and Rosy Cross and the Societas Rosicrucian in Anglia. It is also a key symbol in the 18th degree of the Scottish Rite, representing the dawn of a new era and the eternal nature of life

The Scottish Rite 9th Degree (as communicated by Chat GPT)

endary figure in Masonic lore. It recounts the capture and punishment of the traitors and highlights the moral consequences of their actions.

Key Symbols

Sword and Dagger: Represent vigilance and justice.

Veil or Mask: Symbolizes the uncovering of deceit and the revelation of truth.

Light: Denotes the pursuit of enlightenment and moral clarity.

Moral Lessons

- The necessity of balancing justice with mercy.
- The obligation of a Mason to seek truth and expose wrongdoing while striving to be fair and impartial.
- Vigilance in upholding the integrity of personal and communal values.

The History of Freemasons For the Month of April

April 1— In 1889 was born in Kansas City, MO Bro. Wallace Beery, voted "The world's Best Actor" in 1934 by the International Motion Picture Exposition at Venice, Italy. Bro. Beery ran away from home as a child to become an elephant trainer in a circus. His first job in films was as a female impersonator. He became noted for his character roles. Bro. Beery belonged to Blaney lodge 271 of Chicago, IL, held a 32 deg. AASR, and belonged to the Shrine. He died April 25, 1949.

April 2—In 1875 at Wamego, KS. American motor car manufacturer. His career in the motor industry began with Buick in 1912, but he went on to set up his own corporation and to become a household name. Bro. Chrysler began his career as an apprentice in a railroad machine shop. Soon after he became the manager of the Buick Motor Company and in 1916 was the company's president. He resigned from the Buick Motor Company to oversee Willys-Overland Company and Maxwell Motor Company . In 1925 he merged the two to become The Chrysler Corporation. He died at Great Neck, NY, August 18,. 1940.

April 6—In 1922, the International Order of the Rainbow for Girls founded in McAlester, Oklahoma.

April 9—In 1963 President John F. Kennedy signed a Congressional bill containing these words: "I, John F. Kennedy, President of the United States of America, under the authority contained in an Act of the 88th Congress, do hereby declare Sir Winston Churchill an honorary citizen of the United States of America." Never before had a person been granted honorary U.S. citizenship. Concluding his personal message on signing the bill, President Kennedy said, "By adding his name to our rolls, we mean to honor him -but his acceptance honors us far more. For no statement or proclamation can enrich his name -- the name Sir Winston Churchill is already legend." Although he was half American by birth, Winston Churchill was a British subject throughout his long life. He was, of course, much more than a mere subject of Great Britain: he was the Prime Minister of that country during the time when it defended itself against Nazi Germany. His ties with the United States went far beyond having an American mother. In close cooperation with President and Bro. Franklin Roosevelt, he anchored the alliance that ultimately won the Second World War.


April 12 –In 1902, Bro. James C. Penney opened his first store, in Kemmerer, Wyo. The store was to be the first of what was to become at the time the world's largest department store chain with more than 1700 stores doing annual sales of over \$1-billion. Bro. Penney was born on September 16, 1875 in Hamilton, MO. After the 1929 stock market crash Bro. Penney lost his fortune and wound up beaten and despondent at age 56 and living in a sanitarium. But he proved his method was sound by borrowing money and staging a comeback, which saw him recouping his fortune. He received his degrees at Wasatch Lodge No. 1, Salt Lake City, UT, April 28, May 19, and June 2, 1911. In 1955 he became a dual member of United Services Lodge No. 1118 New York city. He became a member of Utah Chapter No. 1 (RAM), Utah Council No. 1 (R&SM), and No. 1 (K.T.) all at Salt Lake City. In April, 1958, he was presented with the Gold Distinguished Service Award by the General Grand Chapter Royal Arch Masons, at Kansas City, MO. He died in 1971.







